TOWN AND COUNTRY PLANNING 1990.

1. LBC/2026/11. Listed Building Consent for internal alterations at:-
Abarim Chapel House, Llanfachraeth.

No objections.

2. FPL/2025/230. Erection of Shed:-

Refused on Appeal.

The Main reason being the Development Purpose, not conforming with the planning policy, which is trying to safeguard the Countryside and considering the character and district sight.

3. Solicitor Property and Highways Team – Siwan Jones.
Isle of Anglesey Council temporary prohibition of through traffic Llanddeuasant to Llanfigael order.
Pipe relay Welsh Water / Renewing the covering frame. Starting 6th July 2026 (no more than 6 weeks)
Accepted by the Council with no further necessary views.

4. One Voice Wales – Traci Gilmartin.
The Council are accepting the news of importants. Wales Nature week 4th July 2026.
One Voice Wales Bioblitz Bonansa.

5. One Voice Wales – Traci – Gilmartin.
Now open £500 grant for Councils taking first step.
It was discussed by the Council, but it felt that other projects was on going and possibly the application would be to late.

6. Great British Nuclear – Stephen Bray.
The Spark Letter volume 3. Further news accepted by the Council.

7. Dog Foul Bin / Refuse Bin – Cllr. Mrs L Mangan.

The Councillor was eager to use the surplus money collected by the Holland Hotel to go towards Dog Foul Bin a Refuse Bin. Dog Foul Bin by the Village Hall road to the Playing Field. The refuse bin next to Bus Shelter where the children are throwing litter to the gardens. It was debated and decided that the Clerk to obtain estimate for the bins and for emptying. The County Council are not in a position to give bins out, their quota has come to an end. Therefore would have to take them from another village. Prop Cllr. M Woodward, sec Cllr. Mrs M Mangan.

DONATIONS.

8. The Council was very disappointed that no acknowledgement was received for the donation given to Mencap Môn £100.

9. Children Cancer Charity (Swansea)

It was decided unanimously to leave this time. To keep it locally.

10. Approve Audits Llanfachraeth 2025 / 2026.

The Annual Return was put to the Councillors after the return from the Internal Auditor Mr J A Foulkes. They were accepted as correct. The Clerk and Chairman Cllr. W G Roberts signed the form to be sent forward to External Auditor (Welsh Audit Cardiff) Prop Cllr. M Woodward sec Cllr. Mrs L Managan (Unanimous)

11. Llanfachraeth Playing Field.

The Council discussed No 12 (Minutes May 2026) Quarterly Inspection. The Councillors had a look at the necessities. It was decided to send the report to Mac Venture for a quote, they are the only locals. The cost and with the cash being a bit thin, therefore only the necesisty would be considered. Prop Cllr. M Woodward, sec Cllr Mrs G Griffiths.

12. Llanfachraeth Village Hall.

A further debate took regarding the Council becoming Main Co-operate Trustee. There is a great deal of work to be done and 9th June 2026 was the night for a meeting in the Vestry Pont Yr Arw. Unfortunately the main body concerned was not present owing to unforeseen circumstances. The Councillors had a chat only. In tonights meeting it was decided to look for an Independant Group to participate in the running of the Village Hall. With the Council as Main Co-operate Trustee. (Perhaps the Playing field could be amalgamated) The Council and Village Hall would be kept seperate. The Clerk will not be involved in the activities. The records (Secretary) will be independent without any confusion. A seperate night to the Council meeting will have to be arranged.
